1) Resolution No. 9 of 2016: Agreeing to participate in a Tax Increment Financing Plan for the Glass Works Industrial Development Project, a 28.69 acre proposed development site to be constructed for future business and industry. Theron Miles presented the plans for the new industrial park to be located on the former O&I Glass Plant property on Grand Avenue in Clarion and plans to improve the roads surrounding the development.

Evanne Gareis asked for further explanation of the TIF Plan and sales agreement. Clarion County Solicitor Wil White gave a detailed explanation of the purpose of the purchase agreement with the Smiths and the commissioners due diligence on the property. Commissioner Tharan further added details of the cost savings to the county.

Ron Wilshire questioned how the building would be purchased and how much renovations might cost. Commissioner Brosius reported that the Buildings and Grounds Advisory Committee is in full agreement with the purchase. Commissioner Tharan added that the county maintenance department will be doing some of the work as an added cost saver.
